An Ordinance amending Section 71.01.2 of Chapter VII of the Los Angeles Municipal Code to authorize employees of the Department of Transportation to access federal, state and local summary criminal history information.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Section 71.01.2 of Chapter VII of the Los Angeles Municipal Code is amended to read as follows:

SEC. 71.01.2. AUTHORITY OF DESIGNATED EMPLOYEES OF THE DEPARTMENT OF TRANSPORTATION TO HAVE ACCESS TO SUMMARY CRIMINAL HISTORY INFORMATION.

The following persons shall have the authority to obtain federal, state and local summary criminal history information pursuant to the California Penal Code, Section 11105(b)(11) and Section 13300(b)(11), in fulfilling their duties applicable to Chapter VII and Chapter VIII of the Los Angeles Municipal Code: the Board of Transportation Commissioners, the Commission Executive Assistant to the Board of Transportation Commissioners, the Board of Taxicab Commissioners, the Commission Executive Assistant to the Board of Taxicab Commissioners, the General Manager and the Assistant General Manager, the Chief of Transportation Engineer, the Taxicab Administrator, the Senior Transportation Engineer, the Transportation Engineer, the Senior Management Analyst I, the Chief Transportation Investigators, and the Transportation Investigators assigned to or having responsibility for permitting and licensing, and for parking control functions within the Department of Transportation.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
